#### **RAISING THE BAR**

Since establishing her own practice, Anik Pearson has applied planning, design and execution processes that consistently aim to exceed expectations, via reproducible methodologies focused on improving Best Practices, regardless of project type, location, scale, budget, or prestige. She has consistently shown how exceeding minimum standards and providing more than the Basic Services required, not only improves the value and resilience of each project, but also positively influences the wider community, the environment, and the profession.

#### **GROWING VALUE**

As a Board Member of the New York State Board for Architecture, Office of the Professions, Anik lends her voice to public advocacy work, in partnership with AIA Chapters, NCARB, and Regulatory Agencies with a nationwide reach, by taking part in discussions to stem illegal practice, to streamline the DOB application process and databases, as well as discussing methodologies to establish a Best Practices document that other stakeholders in the process can adopt. She is also engaged in efforts to propose regulatory modifications to offer earlier ARE eligibility, thereby providing more choices for students who are on a path toward licensure.

#### **CREATING OPPORTUNITY**

NITY In her advocacy work, Anik leads efforts to support Architecture students at The Cooper Union, through the creation of an endowed scholarship, which is awarded to one student, every year, in perpetuity. The scholarship aims to help incoming students showing promise pay for the full tuition required to attend the Irwin S. Chanin School of Architecture, one of the finest professional educations available. As a member of the John Q. Hejduk Award committee, she contributed to diversity in architecture by nominating and recognizing individuals from disadvantaged and underrepresented groups who have made uncommon and innovative contributions to the profession.

#### **BUILDING EQUITY**

In addition to speaking with secondary school students interested to learn more about a career in architecture and other STEAM careers, Anik regularly hosts college architecture students at her office, to discuss how architecture is a viable field, for all genders. With the objective of encouraging emerging female practitioners to engage with, and to remain in the field, Anik illustrates, through her own example as a sole female practitioner that it is possible to prevail, to have a successful practice, to receive recognition, to be civically engaged, while having a family and securing financial stability. As a Co-Founder of the MWA (Mentorship for Women in Architecture,) Anik leads in efforts to support emerging practitioners by connecting them to the wider community of experienced professionals, to share information, insight, and aspiration, with the goal of energizing leadership, elevating the field, and helping everyone succeed in the field of architecture.
